Dear Chancellor Martin:

I am pleased to inform you Partnership for Education Advancement (Ed Advancement) approved a grant up to the amount of \$42,640.00 for North Carolina A&T State University (“Grantee”) (collectively, the “Parties”) to build its capacity to improve the student outcomes and institutional strength, on the terms and conditions set forth in this agreement (“Grant Agreement”) and consistent with the NCA&T Centralized Advising Letter emailed on 2/17/2023 (Exhibit A, attached).

NOTE: North Carolina A&T State University may be eligible for additional disbursements while the centralized advising program is being developed, however, the potential funding will not exceed the grant amount of \$345,000.00.

1. **Grant Description:**

Purpose: Other: Centralized Advising Infrastructure Start-Up Costs
Area of Support: Transformation Partners

2. **Use of Funds.** The funds associated with this grant (“Grant Funds”) shall be expended in accordance with the projects associated with specific vendors where identified:

- o Centralized Advising Infrastructure start-up costs for 16 professional advisors to cover the following:
 - Cost of laptops (16)
 - Portable dual monitor workstations (16)
 - Cisco phones (16)

Any material changes to the planned activities, expenditures, objectives, milestones, and/or use of Grant Funds described in this Grant Agreement are subject to discussion and pending approval by Ed Advancement in accordance with the grant modification process described in Section 6 below.

3. **Investment Term.** The overall term of the Investment (the “Term”) will begin upon execution of the grant letter and will end on 10/31/2023.

4. **Payment.** Partnership for Education Advancement will directly disburse grant funds to North Carolina A&T State University in accordance with the payment schedule set forth below (the “Payment Schedule”).

5. **Reporting Requirements and Milestones.** Grantee will comply with the following reporting requirements:

September 30, 2023	Status notification of remaining five (5) professional advisors to Relationship Manager, Dr. Sherill Anderson.
October 31, 2023	Documentation on campus letterhead certifying accounting of the items purchased.

- 6. **Grant Modification Requests.** Should Grantee wish to request a modification to the projects, Grantee must contact the Partnership for Education Advancement directly. Project modification requests shall be the exclusive province of Ed Advancement, in its sole discretion. Ed Advancement will promptly review and discuss a request with the Grantee and will provide the Grantee with timely written notice of its approval or denial of the requested modification. Once signed by authorized representatives of both Ed Advancement and Grantee, an approved modification notice shall be incorporated as an addendum to this Grant Agreement.


We look forward to working together in partnership to advance educational opportunities and a more equitable society.
